

## **PROBLEMAS METODOLÓGICOS DE LA BASE DE DATOS DE LA ASOCIACIÓN AMERICANA DE PSICOLOGÍA (APA)**

La base de datos está en el libro de 1995 de Charlotte J. Patterson: *Lesbian & gay parenting* (Washington, DC: American Psychological Association), y puede considerarse un documento oficial de la American Psychological Association (APA). Incluye el registro de 59 libros y artículos publicados en revistas académicas, basados en encuestas directas, por lo cual no son meta-análisis. Además, contiene ocho tesis de doctorado que, como no están publicadas, no las tomaremos en cuenta; sin embargo, es importante mencionar que tienen los mismos problemas metodológicos analizados a continuación.

El más importante de tales problemas, es el carácter sesgado y no representativo de las 59 publicaciones referidas, pues pudimos confirmar que los trabajos estaban basados en muestras muy pequeñas (por ejemplo, 30, 50 o 100 casos), obtenidas por métodos no aleatorios (muestras a conveniencia, entrevistas a participantes de los círculos del movimiento gay, “snowball”, y otros). No hay un solo trabajo que esté basado en muestras representativas de la población, ni siquiera a nivel local. Debido a tales problemas, nos resulta evidente que la publicación de la American Psychological Association es de índole fundamentalmente ideológica, y que no tiene validez científica ni representatividad alguna para conocer lo que sucede en la población general.

En la tabla siguiente se presentan los códigos de clasificación que estamos usando para evaluar este tipo de base de datos. Por ejemplo, el código “1-A-Aa-Ab”, significa que la publicación se refiere a una sola investigación, es de índole científica, es representativa de la población, pero presenta una interpretación sesgada de los datos. Otro ejemplo: una publicación con el código “1-B-Bb” significa que se refiere a una sola investigación, pero tiene problemas metodológicos graves derivados de una muestra muy pequeña de datos.
